I hereby release Flinn, the Host and any of her affiliated organizations from all actions, claims, or demands that I, my assignees, heirs, distributees, guardians, and legal representatives now have or may hereafter have for personal injury, death or property damage resulting for my participation in the above referred Lessons.

I further agree to indemnify, save and hold harmless Deborah Flinn the Host, or any of her affiliated organizations and each of them, from any loss, liability, damage or cost they or any one of them may incur as a result of my attendance at or participation in the above referred Lesson.
